### **VI. NEW BUSINESS:**

#### A. Review of 2022

Nick Holcomb Town Manager reviewed with the Board the following actions that took place in 2022.

1. First Major Subdivision with 42 lots at the end of 2021. Construction documents submitted and reviewed.

- 2. March-rezoned Brick Mill Estates. Construction documents have been approved by the Town and water lines approved by the State.
- 3. July-updated the UDO after one (1) year update and review. Restricted ETJ in areas with no water or sewer infrastructure.
- 4. October-Two (2) rezonings on Highway 27 East with 150 lots and ten (10) acres off of Highway 27 Commercial to Mixed Use.
- 5. Erwin Street-Minor Subdivision. Still waiting to deed Right-of-Way for Public Street.
- 6. Town owns one (1) acre lot between McKinley and Railroad Street.

# B. Objectives and Goals for 2023

Nick Holcomb Town Manager informed the Board that in July or August, a Public Hearing and correction update will be held for the UDO.

Planning Board member Weeks suggested getting together with the people that had complained about the UDO and let them know that Town is working on those updates.

Mr. Holcomb stated that the future land use plan is required by law to be reasonably maintained every five (5) to ten (10) years. The map was done by LKC in 2015 and approved in January 2016. The Board will update the map either in the Fall or next Spring.
